






Overview map 2: Vulnerability of costal sea to pollution from land-based sources




Overview map 3: Population and tourist areas in the coastal zone












Planned land use map 1: Arta Island




Planned land use map 2: Pirovac




Planned land use map 3: Murter - Betina




Planned land use map 4: Murter - Tisno




Planned land use map 5: Tisno - Jezera




Planned land use map 6: Tribunj - Vodice






Planned land use map 8: Prvić - Tijat




Planned land use map 10: Kaprije - Kakan






Planned land use map 12: St. Anthony's channel




Planned land use map 14: Brodarica – Krpanj - Morinje










Planned land use map 18: Primošten - Kremnik














Planned land use map 24: Raslina - Bilice






Planned land use map 26: Skradin




Vulnerability map 1: Coast type




Vulnerability map 2: Terrain elevation




Vulnerability map 3: Wave height






Vulnerability map 5: Current and planned land use




Vulnerability map 6: Cultural heritage
